TERMS AND CONDITIONS OF SALE

IN THE MATTER OF EASTERN MEDIKIT LTD. (IN LIQN.) IN C. P. NO. 516/2012

- 1. That the property in question of the above said company will be sold by inviting sealed tenders on "AS IS WHERE IS AND WHATEVER THERE IS BASIS".
- 2. That the intending purchaser will be allowed inspection of property/assets in order to verify its area and present conditions etc.
- 3. That before submitting their tenders the tenderers should satisfy themselves about the title of the property in question from the concerned authority and the dues/duty payable to them as later on no objection of any kind in this regard shall be entertained by the Hon'ble Court.
