Standing Counsel for Official Liquidator ["OL"], who has accepted the same, without prejudice to her rights and contentions. Mr. Sharma further states that the balance arrears shall be paid on the next date of hearing.

2. Re-notify on 1st August, 2023.

CO.APPL. 19/2023 (for condonation of delay in re-filing)

- 3. For the grounds and reasons stated therein, application is allowed and delay in re-filing CO. APPL. 18/2023 is condoned.
- 4. Disposed of.

CO.APPL. 18/2023 (for modification of order dated 2nd May, 2022)

- 5. Applicant seeks clarification of order dated 02nd May, 2022 passed in C.A. No. 2021. Vide the said order, after forming a prima facie view that Applicant was attempting to usurp the Company's properties, liberty was given to the OL to file an FIR against Directors of the Applicant.
- 6. In the opinion of the Court, since the aforesaid observations were made only on a *prima facie* basis, no modification is necessary. Nonetheless, it is clarified that the observations against the Applicant made in the order shall not be construed as findings of fact, and the investigation in FIR shall proceed independently, on its own merits and evidence, without being influenced thereby.
- Accordingly, the application is disposed of.
